**Explanation of Responses:**

- The option was granted for 5,593 shares on February 29, 2024 and becomes exercisable for 12.5% of the shares on each of the first eight six-month anniversaries of the grant date.
- Restricted stock units convert to common stock on a one-for-one basis.
- The grant of 2,999 restricted stock units vests at 12.5% every six months beginning on September 1, 2024. If a vesting date falls on a day on which the securities exchange is closed, affected RSUs shall vest on the next securities exchange business day.
