**Explanation of Responses:**

- Restricted stock units convert to common stock on a one-for-one basis.
- Shares were withheld by the issuer to satisfy tax withholding obligations in connection with vesting of restricted stock units.
- The option was granted for 11,704 shares on February 28, 2025 and becomes exercisable for 25% of the shares on each of the first four anniversaries of the grant date.
- The grant of 5,476 restricted stock units vests at 25% annually beginning on March 1, 2026. If a vesting date falls on a day on which the securities exchange is closed, affected RSUs shall vest on the next securities exchange business day.
- The grant of 5,383 restricted stock units vests at 25% annually beginning on March 1, 2022. If a vesting date falls on a day on which the securities exchange is closed, affected RSUs shall vest on the next securities exchange business day.
