The ownership of DSRA, LLC is allocated as follows: Ms. Bany 5%, Ms. Bany's spouse 5%, and the remaining 90% is owned by a family trust, for which Ms. Bany's spouse is the trustee. Pursuant to Rule 13d-4, this filing shall not be construed as an admission that Ms. Bany is, for the purposes of Section 13(d) or 13(g) of the Act, the beneficial owner of the securities identified in clause (iv) of this paragraph.
- (b) Ms. Bany's beneficial ownership of Issuer Common Stock represented approximately 4.6% of the Issuer's 33,637,999 issued and outstanding shares of common stock as of December 31, 2011.
- (c) (i) Of the total amount of shares beneficially owned by Ms. Bany, Ms. Bany has sole power to vote or direct the vote of 1,522,512 shares.
