(1) The option grant vests over 4 years with 25% becoming exercisable on each anniversary of the grant date.

(2) Each restricted stock unit represents a right to receive one share of COLM common stock.

25% of the restricted stock units vest annually (a) on the first anniversary of the first day of the first full calendar month following the award date (the "Vest Date"), and (b) on each of the three subsequent anniversaries following the first anniversary of the Vest Date. Vested shares will be delivered to the reporting person on the designated vest dates. If a vesting date falls (3) on a weekend or any other day on which the Nasdaq Stock Market ("NSM") or any national securities exchange on which the Common Stock then is principally traded (the "Exchange")

is not open, affected RSUs shall vest on the next following NSM or Exchange business day, as the case may be.
